### About this role

Student Support Services works with schools and preschools to provide support to assist them in meeting the needs of all children. The role requires the incumbent to participate in the implementation of a service model that supports the provision of integrated and targeted services to meet the needs of children and young people with additional needs.

The trend of increasing learner complexity is well documented in the literature. Increasing numbers of children and young people are being identified with complex learning difficulties and disabilities often with co-existing conditions such as autism and attention deficit/hyperactivity disorder. Increasing numbers of children are in schools who have difficulties arising from premature birth, have survived infancy due to advances in medical interventions, have rare neurological disorders and foetal alcohol syndrome.

Behavioural issues are becoming increasingly more challenging and complex with a range of co-morbidity factors (including mental health) that require skills and expertise to identify underlying causes to better address the needs of the children and young people.



The speech pathologist is a member of a multi-disciplinary team and works with children and young people with speech, language and/or communication issues and their families. The speech pathologist works closely with the senior speech pathologists, speech pathologists, preschool and school staff, and parents to develop evidence-based speech, language and communication interventions that include proactive, targeted and intensive strategies that can be adapted for learning and home contexts. This position works under the professional support and direction of the Senior Speech Pathologist.

Student Support Services are on a cultural response journey, as such we value and prioritise Aboriginal ways of knowing, doing and being.

## What you will do (key outcomes)

1. Apply comprehensive assessment processes to identify speech, language and/or communication issues at an individual level, and with the support of the senior speech pathologist, identify issues at the whole site level.
2. Apply professional knowledge and professional judgment in the selection and adaptation of evidence-based speech, language and communication interventions for individual children and students in the learning environment.
3. Develop multi-levelled interventions that include proactive, targeted and intensive strategies in partnership with preschool and school staff and parents under the professional support and direction of the senior speech pathologist.
4. Provide professional and direct services to individuals with communication needs and support from the senior speech pathologist at the group and whole site level.
5. Under the guidance of the senior speech pathologist, manages and prioritises personal workload by developing workload management plans and provides the senior speech pathologist with workload and capacity updates.
6. Proactively seek opportunities to improve work practices and services, by engaging in professional supervision and professional development.
7. Seek client feedback on services and respond positively to client complaints and feedback, and as required, contribute to investigations of client complaints, with support from the senior speech pathologist, with a view to informing systematic improvements in services.
8. Liaise with non-government and other government organisations in the provision of services particularly with SA Health speech pathologists and NDIS funded speech pathologists.
9. Contribute to the provision of strategic information for the department by adhering to local data

collection requirements identified by the senior speech pathologist.

10. Work with the team to contribute to support positive culturally inclusive environments. Seek to better understand Aboriginal cultural perspectives and take steps to weave these into everyday practice.
11. Help to maintain a safe and healthy working environment by proactively reporting incidents, hazards and injuries.

### The capabilities you will bring (key competencies)

- Demonstrates knowledge gained through achievement of a recognised qualification and can demonstrate an understanding of how this may be applied in the context of a school or preschool to improve the learning and wellbeing outcomes for individuals and groups of children/students.
- Engages with other professionals in needs-based assessments of individuals and development and implementation of evidence-based strategies for change and growth in children and young people.
